



 - -Insufficient data...








Chief Investment Officer Compensation



Executive Director Compensation







The Great Resignation






- 41% of global workforce is likely to consider leaving within next year


- Job Openings and Labor Turnover Survey (JOLTS)






Wage Trends

- Wages and salaries grew
 3.2%
 - -12 month period
 - -June 2021
 - -Civilian (all) workers

ATLANTA FED WAGE TRACKER

- Tracks group over time
- Median wage growth (Sept)
 - -Overall: 4.2%
 - Job Stayer: 3.5%
 - Job Switcher: 5.4%






Wage Indicators

- Annual structure adjustment: 3.2%
- Salary Increase budget: 4.3%

Pay Compression



- Compression exists when inexperienced employees within a grade are paid an identical or similar rate as those with greater tenure
- Evaluate
 - -Calculate target range placement
 - Start date in job
 - Performance
 - How aggressive?
 - How fast
 - Cap increases
