PAS Selection Process (KF/JK/EM)

- SMEs should be utilized during the selection process.
- Work with consultants/SMEs on the functional requirements that pertain to their job duties.
- Enable SMEs to perform detailed proposal review.
- Include SMEs during the product demonstration of a vendor.
- Benefits of SME involvement:
 - Helps to build a team atmosphere with the pension system staff and vendor staff.
 - Provides for better evaluation of the provider's proposed solution.

Preparing the RFP/RFI(KF/JK/EM/DA)

- Public Pension Funds have a fiduciary duty to complete their due diligence of PAS vendors during the RFP/RFI Process.
- Relying on subject matter experts (SMEs)
- Leveraging SME's expertise by including them in the RFP/RFI selection process
- Preliminary requirements in RFP/RFI
 - Input by Consultant
 - Time necessary to write requirements properly (high-level?)

Decision Making Process (DA)

- Decision makers not fully engaged in the project
- Pre-mature decisions (especially without SMEs)
- Delays in making decisions
- Involving SMEs throughout the PAS implementation process
- Project Management – Liaison between Management and Vendor/SME/Consultants

Change Management(DA/KF/JK/EM)

- Changes to services/processes not adequately communicated to key stakeholders
- Don't discount change management: the entire agency should be ready for any changes
- A software platform that will be outdated within the next several years
- Change Requests
 - New legislation passed during a project (PEPRA)
 - New/modified requirements
 - Changes recommended by Board/Legal Counsel

Accurate Data in the New System(JK/DA/EM)

- Preparing a data conversion strategy
- Incomplete and/or poor-quality data in the old system
- Determine how to convert data (cost/benefit)

Project Management Best Practices(DA/EM)

- **Scoping and partnering in discovery discussions**
- **Committed to a vendor during the PAS implementation**
- **Willing to compromise (all parties – vendor, client, and consultant)**
- **Owning what you can do and outsource what you can't do**
- **Implementing RACI (responsible, accountable, consulted, and informed)**

Design(EM/DM/KF/JK)

- Bringing the right staff for JAD (joint application design) sessions
- Managing “nice to have” requests against the budget and time constraints
- Determining who is responsible for design changes and approvals

Project Documentation(DA)

- What types of documentation is required?
 - Record of decisions made
 - Training documentation (i.e., use cases, training guide, test plan)
 - System documentation
 - Design documents
 - Updates to policies and procedures (i.e., organizational assets)
 - What will we need to maintain stability?
- How often should the documentation be updated?

Testing(DA/JK/KF)

- What is the testing strategy?
- Do you have sample test data?
- Describe the testing process?
- What test data needs to be available to run the tests?
- What are the key components of the test plan?
- What is the best way to utilize the consultant or vendor to ensure the testing is complete and accurate?
- Which departmental staff should be involved in testing?
- Should you use third-party vendors to test your data?

Rolling out the PAS to the organization(Team)

- Communicating the key milestones (Employers, management, staff, Board)?
- Identifying Power Users
- What risks should organizations be aware of in the rollout phase?
- Resource commitment
- Managing process and organizational change
- Planning (parallel testing)
- Infrequent processes (1099, interest posting)

Ensuring Business Continuity (Team)

- Disaster recovery plan
- Change request process (cutover process is well planned)
- Handoff from implementation team to support team
- Knowing your vendor's cybersecurity and backup and recovery plan
- Vendor/Consultant support post-production
- Vendor's documentation on customization
- Data security
