



SACRS Legislative Outreach Guide

Throughout the Legislative session, issues may arise where your systems want to reach out to your legislator to share a specific position or concern with a bill. In addition, there may be a time when SACRS takes a position on a bill, and we will coordinate a grassroots lobbying effort that includes outreach by individual systems to their legislative delegation. In either case, your legislators and their contact info are included below. The Capitol address of your legislator should be used to address letters sent on behalf of your system.

If your system takes an individual position on a bill, the position letter should be submitted via the Committee Letter Portal: <https://calegislation.lc.ca.gov/Advocates/>. The instructions for how to submit a letter via the portal are located on the home page. Submitting a letter via this portal allows for your system's position on a bill to be transmitted both to the Author of the bill (and corresponding staff assigned to the bill) and the committee of jurisdiction, ensuring your system's position is included in the Committee Analysis. Position letters should also be sent directly to your legislative delegation via the contact information provided below.

Beyond position letters, to communicate with your legislative delegation directly, you can email your legislator, call, and/or send a hard copy of correspondence to their office using the contact information provided in the SACRS Legislative Delegation Assembly and Senate document.
